## ENTRANCE REQUIREMENTS

1. **EDUCATION** - A high school diploma from an approved agency or a GED is required for entrance to most programs. Home school students requesting admission who did not attend a recognized accredited program must submit a Certificate of Attendance form from the local superintendent's office or a Declaration of Intent from the Georgia Department of Education along with annual progress reports or a final transcript from junior and senior years including the graduation date.
2. **Eligible Applicants:** Individuals 16 years of age or older or dually enrolled high school students in the 9th, 10th, 11th or 12th grades who seek access to quality instruction at the post-secondary level are eligible for admissions.
